# DR. GARY ROSE NAMED 2011 PROFESSOR OF THE YEAR

Dr. Gary Rose was named 2011 Connecticut Professor of the Year by The Carnegie Foundation for the Advancement of Teaching and the Council for Advancement and Support of Education (CASE). Dr. Rose was selected from nearly 300 top professors nominated by colleges and universities throughout the United States.

Dr. Rose joined the Sacred Heart University faculty in 1982 and is currently chairman of the Department of Government and Politics. He is passionate about introducing students to the political system and how it operates. "My inspiration comes from a firm belief that students can, if they so desire, make a profound difference in American politics. I believe in the old axiom that 'knowledge is power.' So, in essence, my mission as a university professor is to objectively expand the political knowledge of my students so they in turn can participate effectively in the political process and help shape public policy," Dr. Rose said. "I'm very proud of the large number of graduates from our political science program who have, in one form or another, entered public service and are working for the common good.

The award was presented at a luncheon held in the Newseum in Washington, D.C. and followed by a congressional reception at the Folger-Shakespeare Library.

## **Internships**

The mission of the Department of Government and Politics is to prepare students for public service. To that end, we continue to maintain a very active and educational internship program. During AY 2011-12, Political Science students served as interns at the Connecticut State Capitol, the U.S. District Attorney's Office, law offices, and a local police department. We also placed a student on a Bridgeport mayoral campaign, and several students are working this summer on congressional and senate campaign staffs. Most of our students who serve as interns receive academic credit for their experience. Our internships have also served as useful stepping stones to public service careers.

#### POLITICAL SCIENCE ALUMNUS BECOMES MONROE TOWN COUNCIL CHAIR

Nick Kapoor '11 was recently selected as the Democratic Chairman for the town of Monroe, Connecticut. Nick is the one of youngest party chairman in the state of Connecticut. He is also a member of the Monroe Town Council. As the chairman of his local party, Nick led his town's delegation to the Democratic State Convention on May 12, 2012, where he announced his town's delegate vote for the party's candidates for U.S. Senate. For this year's newsletter, I asked Nick to provide an account of his first convention experience. His fascinating narrative follows:

As I walked up to Kaiser Hall on the Central Connecticut State University campus, I had no idea what to expect. And then I saw it, 1800+ Democrats in one place; I thought I had died and gone to heaven. I got my credentials and as Monroe's Chair, the "packet." I walked onto the floor of the convention searching for Someone pointed me to the Monroe. bleachers because the 2<sup>nd</sup> and 4<sup>th</sup> CDs were in the bleachers and the 1st, 3rd and 5th CDs were on the floor. Monroe was in the nosebleed seats. We were literally 3 rows from the back wall. Monroe doesn't have too much pull in the Democratic Party since it is quite a Republican town.



The ceremonies started with all the fanfare of a convention. Senator Blumenthal gave opening remarks, dignitaries were introduced and housekeeping rules were adopted. Governor Malloy nominated Chris Murphy who was seconded by State Senator Beth Bye. Susan Bysiewicz and Matthew Oakes were also nominated. Lee Whitnum didn't show and wasn't nominated.

Both campaigns had excellent floor operations. I, personally, was wavering right up until I announced the vote. I was contacted by at least 3 or 4 representatives from each campaign. Also, they broke it down by CD, so each campaign had representatives stay with each CD, since that's how we were seated, to make sure their whip counts were what they were expecting. Governor Malloy, Lt. Governor Wyman and State Rep William Tong were all making their rounds making sure the delegates knew which candidate they favored and therefore which candidate the delegates should favor.

The next step was the roll call. The rules committee of the DSCC voted a few nights prior to call up each town alphabetically by CD starting with the Ist and ending with the 5th. At the end of each CD, the Chairs would be able to come up and change their delegation's votes if delegates had changed. After the Ist CD, Susan was not trailing by as much as I thought she would be, but then after Windsor Locks was called, Berlin and I believe one other town changed their votes to favor Murphy. As I was waiting in line to announce Monroe's total, I had representatives from both campaigns check back to make sure we were absolutely final like I said, two commendable floor operations. I announced Monroe's total and then the 5th CD finished up. One last round of the opportunity to change followed for each CD and the roll call was over.

Congressman Chris Murphy took 1,378 (75.59%) delegates, former Secretary of State Susan Bysiewicz took 444 (24.36%) and Matthew Oakes took I (0.05%) delegate. The person who seconded Oakes's nomination didn't even vote for him. Monroe was the only municipality in the 4<sup>th</sup> CD to award a majority of its delegates to Bysiewicz. Bysiewicz took the majority or all of the delegates in only 23 out of 169 towns and cities across Some were ties and then Connecticut. Murphy took the majorities or the entire delegations of the rest. Also, the 5th district went almost exclusively to Chris Murphy. Bysiewicz's hometown of Middletown split 22 - 6. One would think if Chris Murphy could carry his entire congressional district, but Bysiewicz couldn't even win all of the delegates in her hometown, then perhaps she's in more trouble than some think. It'll be interesting to see how close the primary numbers are to the convention total. Will Murphy win the primary 75% - 25%? Is the

nominating convention a good harbinger of the primary?

After the tally was announced, the Murphy campaign stormed the stage to wait to hear from the party's nominee. Susan's team formed a circle around her holding up Bysiewicz signs and chanting Susan and cheering. However, Chris Murphy's congratulatory music started blasting throughout the hall and the Bysiewicz team left the floor.



Overall, it was an amazing day. Being one of the youngest Town Chairs - if not the youngest in the State - I was truly honored to be able to represent Monroe at the microphone. The camaraderie that is felt by having all of your fellow party members in one room is really an amazing feeling. As far as the candidates, they were both extremely impressive. The way the "floor was worked" was very interesting to see right in front of my own eyes; "politics" at work. Or perhaps you could say "working the convention floor" is almost the politics of politics. It was also interesting to see how Governor Malloy could walk up to a delegate who was wavering, shake his or her hand, talk to them for a few minutes, and change their vote to Murphy after months of the Bysiewicz campaign probably working on that person. The Governor was king-like in his presence at the convention. I would suspect this to be the case when there is a Republican Governor at a Republican convention, but it was really a sight to see. In conclusion, I had an amazing day and can't wait for the 2014 convention!

## Faculty Scholarship

The Department's four full-time faculty continue to be very active with respect to new course development, student mentoring, and publishing within their respective academic fields. We are exceptionally proud of the Political Science faculty's sustained commitment to teaching excellence and professional scholarship. A listing of the faculty's activity follows:

Lesley DeNardis, Ph.D. published two refereed articles: "The Politics of Reorganizing Connecticut State Government: Altering Administrative Structures in the Land of Steady Habits" (2011), Journal of Public Administration and Governance, Vol. 1; and "Keeping the Lid on Charter Schools: The Politics of Education Reform in Connecticut" (2012), New England Journal of Political Science. She also delivered a lecture on educational policy in Connecticut for the Sacred Heart University Center for Urban Policy and Action. This was the inaugural event of this recently established institute. She continues to serve on the Hamden Board of Education and the Advisory Board of Sacred Heart Academy in Hamden, Connecticut. And a big congratulations to Dr. DeNardis for receiving tenure and promotion at Sacred Heart University.

**Alka Jauhari, Ph.D.** published a refereed article: "Africa's Economic Resurgence: Is it Possible? Africa Review (2012). And congratulations to Dr. Jauhari for receiving her 15 year service award at the Founder's Day Ceremony in April.

**Steve Michels, Ph.D.** continued to make sustained progress on his book-length manuscript titled *The Case Against Democracy.* He also authored a reflective essay regarding his sabbatical leave for the *Chronicle of Higher Education.* 

Gary L. Rose, Ph.D. published his tenth book titled Connecticut's Fourth Congressional District: History, Politics and the Maverick Tradition. A book signing and public delivery in the university's library accompanied the release of his latest work. He continues to serve as a guest speaker regarding the 2012 election for civic organizations throughout the state, and served as the moderator of the first formal debate between former Secretary of State Susan Bysiewicz and Congressman Chris Murphy, the two candidates competing for the Democratic party's nomination for U.S. Senate.

He also served as the moderator of an oncampus debate between nationally renowned journalists Tucker Carlson and Eugene Robinson. This forum was sponsored by the Office of Student Affairs. Dr. Rose continues his work as a commentator for national, state and local media. He received his 30 year service award at the Founder's Day ceremony in April.

#### Brian Marks, J.D., Ph.D.


teaches two Political Science electives during the academic year: "Modern Political Economy" and "Middle East Politics."

RALPH M. STEIN, J.D.

PROFESSOR OF LAW, PACE UNIVERSITY SCHOOL OF LAW
"FIRST AMENDMENT RIGHTS IN THE AGE OF SOCIAL MEDIA"

Professor Stein is a founding member of the Pace Law School faculty. His areas of expertise include constitutional law, first amendment freedoms, legal history, criminal law and torts. He was largely responsible for uncovering military surveillance of civilian political activity in the early 1970s. He served for two years as a field investigator for the U.S. Senate Sub-Committee on Constitutional Rights, and currently serves on the Board of Directors of the Lower Hudson Valley Chapter of the New York Civil Liberties Union.

# PRESIDENTIAL INAUGURATION TRIP TO WASHINGTON, DC

Dr. Rose will once again be coordinating his quadrennial trip to the nation's capital for the 2013 presidential inauguration. This will be his eighth inauguration trip. According to the U.S. Constitution, January 20<sup>th</sup> is the official day for swearing the President into office. However, because January 20<sup>th</sup> falls on a Sunday, the President will be sworn in during a private ceremony. On Monday, January 21<sup>st</sup>, the President will once again be administered the oath of office in a public ceremony. More than 2 million people attended President Obama's inauguration in 2009! The forthcoming inaugural trip is scheduled for January 19-21, 2013.
