plished scholar, mentor and friend to literally thousands of students, Dr. K. decided to retire after 37 years of teaching, 28 of which were on the campus of Sacred Heart University. The Department of Government and Politics hosted a special reception for Dr. K. which was attended by many of his current and former students. E-mails and gifts arrived from across the globe in honor of this master educator. Dr. K. delivered his "last lecture" in the Schine Auditorium which was attended by more than one hundred students, faculty and staff. He reflected on the state of international politics, orga-

nizational management, and his career as a professor. A standing and lengthy ovation followed which brought tears to everyone's eyes. It was truly a moving experience and one that we will cherish forever. The Department of Government and Politics and Sacred Heart University will not be the same without Dr. K. THE DR. JOHN F. KIKOSKI POLITICAL SCIENCE SCHOLARSHIP

In honor of our retiring colleague, Sacred Heart University has established a scholarship in Dr. K's name. Enclosed in this issue of the newsletter is a pledge card which allows alumni to participate as donors to this

newly established and prestigious scholarship. The annual recipient of the Dr. John F. Kikoski scholarship will be a senior political science major in excellent academic standing. The recipient will be expected to have a particular interest in the field of international politics. The scholarship will be funded through alumni contributions and awarded at the annual Pi Sigma Alpha induction ceremony in late spring.

Constitution Day

The third annual "Constitution Day" lecture was delivered on September 17th 2007 before a large audience in the Edgerton Theater. Our guest speaker this year was United States Congressman Christopher Shays. Congressman Shays, a moderate Republican who represents the Fourth Congressional District in Connecticut, discussed the war in Iraq as well as his personal experiences and observations acquired during his eighteen visits to this volatile and war torn country. Congressman Shays noted the slow but steady progress with respect to Iraq's political development and expressed optimism about Iraq's future as a democracy. A lively question and answer period followed the Congressman's formal delivery.

Visit By Connecticut Supreme Court Justice

On March 1, 2008, Connecticut Supreme Court Justice Barry A. Schaller visited Sacred Heart University. Justice Schaller participated in a luncheon with pre-law students and faculty. The luncheon was followed by a public delivery in the Board Room of the William H. Pitt Center. Justice Schaller's public presentation was titled: "Courts, Constitutions and Public Policy." Justice Schaller will return to Sacred Heart in September as our guest speaker for the annual "Constitution Day" lecture.

Presentation By United States Secret Service

On March 29, 2008, the Department of Government and Politics in conjunction with the Department of Criminal Justice hosted a special forum conducted by two Special Agents from the United States Secret Service. The two hour forum, held in the Edgerton Theater, featured a film re-

garding the Secret Service, a power point presentation, equipment demonstrations, and an excellent discussion by the agents concerning internship and career opportunities.

Pi Sigma Alpha Induction

On April 18, 2008, thirteen outstanding political science students were inducted into Pi Sigma Alpha, the national political science honor society. The guest speaker this year was Ms. Eileen Heaphy. Ms. Heaphy is a retired Foreign Service Officer with the U.S. State Department. She reflected on her many intriguing experiences in Latin America and Western Europe and fielded questions concerning career opportunities. Ms. Heaphy is currently an adjunct instructor for the Department of Government and Politics.

Student Awards

The Gold Medal for Academic Excellence in Political Science was awarded to Mr. Stephen Winter. The Silver Medal for Academic Excellence in Political Science was awarded to Ms. Maureen Curtis. Mr. Jason Guberman-Pfeffer was the recipient of the recently established Evelyn Conley Scholarship awarded to a promising pre-law political science major. Jason also authored a scholarly article titled "Truth and Falsehood: Islamists on Their Own Terms" in *Global Perspectives*, Spring, 2008, pp. 45-54. This publication is an undergraduate international affairs journal published by the Occidental College Office of Global Affairs. Jason's article was completed under the advisement of Dr. Kikoski as a component of his capstone course for the minor in Middle Eastern Studies.

Ms. Whitney Wildman, a political science major in the University's Honors Program, attended the National Education for Women's (NEW) Leadership Institute at St. Anselm's College in June, 2008.

Political Science Internships

For the 2007-08 Academic Year, students served as interns at the Connecticut state

Capitol, on the staff of Congressman Christopher Shays, in local law offices, and at Reed Exhibitions in Norwalk, Connecticut. Students received academic credit for their experiences and gained valuable contacts for the purpose of future employment. The 36 credit major in political science allows students to complete up to nine internship credits. Active and engaged learning remains a central feature of the political science experience at Sacred Heart University.

Graduate School Placement

Ms. Teresa Fennell has been accepted into the graduate program in criminal justice at Sacred Heart University. Teresa completed her political science degree at Sacred Heart in three years.

Dr. Thomas P. Melady's Op-Ed.

Dr. Thomas P. Melady, Senior Ambassador in Residence at the Institute for World Politics, penned an op-ed for the Washington Post regarding Pope Benedict XVI's visit to the U.S. "The Papal Visit," April 2, 2008. Dr. Melady is a former Ambassador to the Holy See, Uganda and Burundi. He is also President Emeritus at Sacred Heart University and an honorary alumnus of the political science program.

Full-Time Faculty News

Dr. Lesley DeNardis published a co-authored article "Financial Performance in Connecticut's Municipalities: A Comparison of Manager, Mayor Council and Selectman Forms of Government" in the *New England Journal of Political Science*, Volume II, No. 2. A second co-authored article is forthcoming: "Assessing Competition Policy Performance Metrics: Concerns About Cross Country Generalizability" in *Indian Journal of Economics and Business*, Volume 7, No. 1. In addition to her publications, Dr. DeNardis presented three professional papers regarding municipal government in Connecticut. Her papers were delivered at the Joseph W. Martin Jr. Institute for Law and Society, Stonehill College in Massachusetts, and the New England Political Science Association Annual Meeting in Rhode Island. Her current research projects involve charter revision in two Connecticut communities, and

school finance reform in Connecticut. She recently received a scholarship grant from the University which will support her research efforts. Dr. DeNardis is a participant this summer in the President's Seminar on the Catholic Intellectual Tradition.

Dr. John Kikoski's short-term research plans mainly involve: (a) travel within this grand country by automobile to see and appreciate more of the United States' beaches and mountains, prairies and people; and (b) travel abroad to visit France where Mrs. Kikoski has close family and childhood friends. Longer-term academic research (which is already underway) involves revisions of two previous books on managing culturally diverse workgroups, as well as inquiry within organizations. A newer project involves research on innovation and creativity.

Dr. Steven Michels was appointed the new Director of the Thomas More Honors Program. He replaced Dr. Walter Brooks who served as Honors Director for several years. The Honors Program is a unique program of study at Sacred Heart University for a highly select category of students. Dr. Michels was also granted tenure and promotion to the rank of Associate Professor, an important professional milestone. We congratulate him on this achievement. Dr. Michels' scholarly activity resulted in a co-authored publication "Can The Daily Show Save Democracy?" in *The Daily Show and Philosophy*, ed. Jason Holt (Malden, MA: Blackwell Press, 2007): 81-92. Additionally, Dr. Michels completed three articles currently under review for publication in professional journals, served on the editorial board of and referee for *Scientific Journals International*, and served as political theory section chair at the New England Political Science Association's Annual Conference in Rhode Island. Dr. Michels' current research project involves the philosophy of Thomas Hobbes.

Dr. Gary Rose published two books during the 2007-08 Academic Year. *Connecticut Government and Politics: An Introduction* (Fairfield: Sacred Heart University Press, 2007), and *The Emerging Catholic Electorate: Political Perspectives of College Students at a Catholic University in the Northeast* (Mason, OH: Thomson, 2008). He authored a magazine article "The Youth Vote in 2008: Up for Grabs or Staying

Home?" in *The Ripon Forum*, December 2007/January 2008, Vol. 41, No 6: 17-19, and authored an op-ed: "As Maine Goes, So Should Connecticut" in *The Connecticut Post*, August 12, 2007. He offered extensive commentary regarding the presidential nominating contest for local, state and national media. He is formulating plans for a fresh research project over the summer.

Adjunct Faculty News

Ms. Louise DiCocco-Beauton, Esq. once again taught her popular elective on lobbying and the legislative process. Ms. DiCocco is the lobbyist for the New Haven Chamber of Commerce. Her course features an array of guest speakers, a trip to the state Capitol, and unique insight into practical politics.
